Special Mooring Conditions

1. Mooring fees are payable in advance and no credit can be allowed. Overdue accounts will be surcharged at 2% per month.
2. No refund will be given for unused mooring,
3. Water levels are not guaranteed and it is the Owner's responsibility to ensure that the boat is secured in such a way as to cope with water level fluctuations.
4. All boats agree to maintain a valid BW license, Boat Safety Certificate and the minimum third party insurance.
5. Mooring fees do not include the storage of boat trailers. Where space permits trailers can be stored at an agreed cost and position.
6. Each Mooring is allowed parking for up to two vehicles. Additional vehicles will be charged.
7. Craft using the Moorings must not be used residentially.
8. No for sale signs may be displayed on boats whilst in the Marina.
9. All Public Relations communications must be to be through and approved by the Company.
10. No Fishing.
